

ORDINANCE NO. 2447

AN ORDINANCE appropriating \$125,988 from previous year's appropriations to various swimming pool projects to the Vashon Pool project, and revising the 1975 Park Capital Improvement Budget; and amending Ordinance No. 2230, Section 69, Attachment No. 1, as amended, and declaring an emergency.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. There is hereby approved and adopted an appropriation of \$125,988 from previous year's appropriations to various swimming pool projects to the Vashon Pool Facility (Project No. 090163);
