ORDINANCE NO. 2474

AN ORDINANCE amending King County Zoning Resolution No. 25789, as amended, by amending the Zoning Map thereof reclassifying certain property thereon at the request of George Filler Division of Land Use Management File No. 102-74-P.

BE IN ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. George Filler petitioned on December 17, 1973, that the property described in Section 3 below be reclassifed from B-C to RM-1800 and this application was assigned Division of Land Use Management File No. 102-74-P.

SECTION 2. The report and recommendation of the Division of Land Use Management was transmitted to the Zoning and Subdivision Examiner on February 19, 1974, and hearing was held by the Examiner on the matter February 26, 1974 and April 2, 1974. The report of the Examiner was filed with the Clerk of the King County Council on April 17, 1974 and the Council approved the reclassification by Motion No. 1725 on August 19, 1974, subject to conditions which have now been satisfied.

SECTION 3. The legal description of the property to be reclassified is attached as Appendix A and is hereby made a part of this ordinance. The above described property is shown on the attached map which is designated Appendix B and is hereby made a part of this ordinance.

SECTION 4. The King County Council does hereby amend King County Zoning Code, Resolution No. 25789, as amended, by reclassifying that property
