ORDINANCE NO. 2475

AN ORDINANCE amending King County Zoning Resolution No. 25789, as amended, by amending the Zoning Map thereof reclassifying certain property thereon at the request of Roy G. Utter, Division of Land Use Management File No. 221-74-P.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Roy G. Utter petitioned on March 21, 1974, that the property described in Section 3 below be reclassified from RD 3600 to RM 2400 and this application was assigned Division of Land Use Management File No. 221-74-P.

SECTION 2. The report and recommendation of the Division of Land Use Management was transmitted to the Zoning and Subdivision Examiner on May 21, 1974, and hearing was held by the Examiner on the matter May 28, 1974. The report of the Examiner was filed with the Clerk of the King County Council on June 12, 1974, and the Council approved the reclassification by Motion No. 1603 on June 17, 1974, subject to conditions which have now been satisfied.

SECTION 3. The legal description of the property to be reclassified is attached as Appendix A and is hereby made a part of this ordinance. The above described property is shown on the attached map which is designated Appendix B and is hereby made a part of this ordinance.

SECTION 4. The King County Council does hereby amend King County Zoning Code, Resolution No. 25789, as amended, by reclassifying that property described and shown in Section 3, Appendices A and B above, to RM 2400 and directs that Area Map W19-23-4 be modified to so designate.
