ORDINANCE NO. 2489

AN ORDINANCE amending King County Zoning Resolution No. 25789, as amended, by amending the Zoning Map thereof granting Unclassified Use Permit on certain property at the request of Vashon Sewer District, Division of Land Use Management File No. 114-75-U.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Vashon Sewer District petitioned on January 28, 1975, for an Unclassified Use Permit on the property described in Section 3 below to allow a Wastewater Treatment Facility and this application was assigned Division of Land Use Management File No. 114-75-U.

SECTION 2. The report and recommendation of the Division of Land Use Management was transmitted to the Zoning and Subdivision Examiner on April 22, 1975, and hearing was held by the Examiner on the matter April 29, 1975. The report of the Examiner was filed with the Clerk of the King County Council on May 14, 1975, and the Council approved the Unclassified Use Permit by Motion No. 1993 on May 19, 1975.

SECTION 3. The legal description of the property is attached as Appendix A and is hereby made a part of this ordinance. The above described property is shown on the attached map which is designated Appendix B and is hereby made a part of this ordinance.

SECTION 4. The King County Council does hereby amend King County Zoning Code, Resolution No. 25789, as amended, by granting an Unclassified Use Permit for a Wastewater Treatment Facility on that property described and shown in Section 3, Appendices A and B above, and

directs that Area Map W 29-23-3 be modified to so designate.
