ORDINANCE NO.

AN ORDINANCE amending King County Zoning Resolution No. 25789, as amended, by amending the Zoning Map thereof reclassifying certain property thereon at the request of Weyerhaeuser Real Estate Co., Division of Land Use Management File No. 221-75-R.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Weyerhaeuser Real Estate Co. petitioned on February 14, 1975, that the property described in Section 3 below be reclassified from SR (Potential RM 900) to RM-900 and this application was assigned Division of Land Use Management File No. 221-75-R.

SECTION 2. The report and recommendation of the Division of Land Use Management was transmitted to the Zoning and Subdivision Examiner on June 3, 1975, and hearing was held by the Examiner on the matter June 10, 1975. The report of the Examiner was filed with the Clerk of the King County Council on July 16, 1975, and the Council approved the reclassification by Motion No. 2124 on September 2, 1975 subject to conditions which will be satisfied as per Ordinance 2423, "P" suffix.

SECTION 3. The legal description of the property to be reclassified is attached as Appendix A and is hereby made a part of this ordinance. The above described property is shown on the attached map which is designated Appendix B and is hereby made a part of this ordinance.

SECTION 4. The King County Council does hereby amend King County Zoning Code, Resolution No. 25789, as amended, by reclassifying that property described and shown in Section 3, Appendices A and B above, to RM 900 -P and
