AN ORDINANCE amending King County Zoning Code, Resolution No. 25789, as amended, by amending the Zoning Map thereof adopting a Unclassified Use Permit on certain property thereon at the request of Ben Jones, Division of Land Use Management File No. 100-75-U.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Ben Jones petitioned on November 14, 1974, that the Unclassified Use Permit be adopted on property described in Section 3 below and this application was assigned Division of Land Use Management File No. 100-75-U.

SECTION 2. The report and recommendation of the Division of Land Use Management was transmitted to the Zoning and Subdivision Examiner on January 1, 1975, March 25, 1975, and August 5, 1975, and hearing was held by the Examiner on the matter January 14, 1975, February 11, 1975, April 1, 1975 and August 12, 1975. The report of the Examiner was filed with the Clerk of the King County Council on September 10, 1975, and the Council approved the reclassification by Motion No. 2157 on September 15, 1975, subject to conditions which have now been satisfied.

SECTION 3. The legal description of the property designated is attached as Appendix A and is hereby made a part of this ordinance. The above described property is shown on the attached map which is designated Appendix B and is hereby made a part of this ordinance. The development plan is designated Appendix C and is hereby made part of this ordinance.

SECTION 4. As provided for in King County Zoning Code Resolution No. 25789, as amended, the King County Council does hereby grant the unclassified use permit
