## ordinance no. 2587

AN ORDINANCE relating to the annexation of an area known as Lake Wilderness to Cascade Sewer District.

WHEREAS, Cascade Sewer District has found the petition for annexation of an area known as Lake Wilderness to be sufficient and has, by resolution, concurred with the proposed annexation; and

WHEREAS, state law requires approval of the proposed annexation by the King County Council and the King County Boundary Review Board; and

WHEREAS, the King County Council finds said annexation is in the public interest and is not inconsistent with the county comprehensive plan;

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation by Cascade Sewer District of the area known as Lake Wilderness and described in Section 2 herein is approved.

SECTION 2. The area known as Lake Wilderness to be annexed is described as follows:

Beginning at the point of intersection of the centerline of Witte Road Southeast with the South line of Section 21, Township 22 North, Range 6 East, W.M., in King County, Washington, also being a point on the existing Cascade Sewer District boundary:

Thence Northerly along said centerline to its intersection with the East-West centerline of said Section 21;

Thence Easterly along said centerline to its intersection with the West line of the East half of the East half of said Section 21;

Thence Southerly along said West line to its intersection with the North line of the South one-half of Government Lot 3 of said Section 21;

Thence Easterly along said North line to its intersection with the centerline of West Lake Wilderness Drive, S.E.;

Thence Southerly along said centerline to its intersection with the centerline of 226th Place, S.E.;

Thence along the centerline of said 226th Place S.E. to its intersection with the South line of Section 21, also being the North line of Section 28, Township 22 North,

1 Range 6 East, W.M.; Thence continuing Southerly along the centerline of 2 266th Place, S.E. as whown on the Plat of Lake Wilderness 5 Acre Tracts as recorded in Volume 20 of Plats, 3 page 27, records of King County, Washington to its intersection with the East-West centerline of said Section 28; 5 Thence South 21 25'34" West 79.32 feet along the centerline of 226th Place S.E. as shown on said plat of 6 Lake Wilderness 5 Acre Tracts; 7 Thence South 70 08'00" East 199.45 feet; 8 Thence North 60 59'00" West 242.56 feet; 9 Thence South 17 33'00" East 188.60 feet; 10 Thence South 36 39'30" West 239.50 feet; 11 Thence South 25 02'00" West 325 feet more or less to the centerline of Witte Road S.E.; 12 Thence Southerly along the centerline of said Witte 13 Roade S.E. to the South line of said Section 28; 14 Thence Westerly along the South line of said Section 28 15 to the Southwest corner thereof, also being the Southeast corner of Section 29, Township 22 North, Range 6 16 East, W.M.; 17 Thence continuing Westerly along the South line of said Section 29 to its intersection with the West line of the East half of said Section 29; 18 Thence Northerly along the West line of said East half 19 to its intersection with the South line of the North half of the North half of said Section 29; 20 Thence Easterly along said South line to the East line 21 of said Section 29; also being the West line of said 22 Section 28; 23 Thence Southerly along the West line of said Section 28 to its intersection with the Northerly margin of Silvan Road (S.E. 261st St.) as platted in the Plat of Pipe 24 Lake and Lake Lucerne as recorded in Volume 28 of Plats, page 49, records of King County, Washington. 25 Thence along the Northerly margin of said Silvan Road 26 Easterly (S.E. 261st St.), Northeasterly (215th Place S.E.) and Easterly (S.E. 258th St.) to its intersection 27 with the East line of the West half of the West half of said Section 28; 28 29 Thence Northerly along said East line to the North line of said Section 28; also being the South line of said 30 Section 21; 31
