ORDINANCE NO. \_\_\_\_\_

AN ORDINANCE relating to charging fees for family planning services provided by the Seattle-King County Department of Public Health and establishing fee schedule.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

NEW SECTION. SECTION 1. Family Planning. The Director of the Department of Public Health is hereby authorized and directed to make a charge for the provision of family planning services and supplies. These services can include but are not limited to a physical examination, urine examination, hematocrit, and birth control consultation.
