## ordinance no. 2629

AN ORDINANCE relating to the annexation of an area known as 69-26R to Southwest Suburban Sewer District.

WHEREAS, Southwest Suburban Sewer District has found the petition for annexation of an area known as 69-26R to be sufficient and has, by resolution, concurred with the proposed annexation; and

WHEREAS, state law requires approval of the proposed annexation by the King County Council and the King County Boundary
Review Board; and

WHEREAS, the King County Council finds said annexation is in the public interest and is not inconsistent with the county comprehensive plan,

THEREFORE, BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation by Southwest Suburban Sewer District of the area known as 69-26R and described in Section 2 herein is approved.

SECTION 2. The area known as 69-26R to be annexed is described as follows:

That portion of the N.E. 1/4 of Section 1, Township 23 North, Range 3 East, W.M., described as follows:

Beginning at the intersection of the centerline of S.W. Roxbury St. (North line of said N.E. 1/4) with the centerline of 21st Ave. S.W.;

Thence Southerly along the centerline of said 21st Ave. S.W. to its intersection with the centerline of S.W. 98th St.;

Thence Easterly along said centerline to its intersection with the Easterly margin of said 21st Ave. S.W.;

Thence Southerly along said Easterly margin to its intersection with the Northerly margin of S.W. 100th St.;

Thence Easterly along said Northerly margin to its intersection with the Northerly extension of the East line of the alley in Block 2, of Regal Heights Addition, according to plat thereof recorded in Volume 20 of Plats, page 94, records of King County, Washington;

Thence Southerly along said East line and its Northerly and Southerly extensions to its intersection with the centerline of S.W. 102nd St.;
