ordinance no. 2637

AN ORDINANCE amending King County Zoning Resolution No. 25789, as amended, by amending the Zoning Map thereof reclassifying certain property thereon at the request of Allied Enterprises, Building and Land Development File No. 246-75-R.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Allied Enterprises petitioned on June 27, 1975 that the property described in Section 3 below be reclassified from RS-7200 to RM-900 and this application was assigned Building and Land Development Division File No. 246-75-R.

SECTION 2. The report and recommendation of the Building and Land Development Division was transmitted to the Zoning and Subdivision Examiner on August 19, 1975 and hearing was held by the Examiner on the matter August 26, 1975. The report of the Examiner was filed with the Clerk of the King County Council on September 18, 1975 and the Council approved the reclassification by Motion No. 2178 on September 29, 1975 subject to conditions which will be satisfied as per "P" suffix.

SECTION 3. The legal description of the property to be reclassified is attached as Appendix A and is hereby made a part of this ordinance. The above described property is shown on the attached map which is designated Appendix B and is hereby made a part of this ordinance.

SECTION 4. The King County Council does hereby amend King County Zoning Code, Resolution No. 25789, as amended, by
