BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:


SECTION 1. The Boathouse petitioned on November 26, 1974 that the property described in Section 3 below be reclassified from B-C to C-G and this application was assigned Division of Land Use Management File No. 207-75-R.

The report and recommendation of the Division SECTION 2. of Land Use Management was transmitted to the Zoning and Subdivision Examiner of January 21, 1975 and hearing was held by the Examiner on the matter January 28, 1975 and February 11, 1975. The report of the Examiner was filed with the Clerk of the King County Council on March 5, 1975 and the Council approved the reclassification by Motion No. 1903 on March 10, 1975 subject to conditions which have now been satisfied.
