ORDINANCE NO.

AN ORDINANCE amending King County Zoning Resolution No. 25789, as amended, by amending the Zoning Map thereof reclassifying certain property thereon at the request of R.D. Abendroth, Division of Land Use Management File No. 141-75-R.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. R.D. Abendroth petitioned on July 15, 1975, that the property described in Section 3 below be reclassified from RM-900 to C-G and this application was assigned Division of Land Use Management File No. 141-75-R.

SECTION 2. The report and recommendation of the Division of Land Use Management was transmitted to the Zoning and Subdivision Examiner on September 2, 1975, and hearing was held by the Examiner on the matter September 9, 1975. The report of the Examiner was filed with the Clerk of the King County Council on October 1, 1975, and the Council approved the reclassification by Motion No. 2275 on January 19, 1976, subject to conditions which will be satisfied per the "P" suffix.

SECTION 3. The legal description of the property to be reclassified is attached as Appendix A and is hereby made a part of this ordinance. The above described property is shown on the attached map which is designated Appendix B and is hereby made a part of this ordinance.

SECTION 4. The King County Council does hereby amend King County Zoning Code, Resolution No. 25789, as amended, by reclassifying that property described and shown in Section 3, Appendices A and B above, to C-G-P and directs that Area Map W 7-26-4 be modified to so designate.
