ORDINANCE NO.

AN ORDINANCE amending King County Zoning Resolution No. 25789, as amended, by amending the Zoning Map thereof reclassifying certain property thereon at the request of J. Shane Cadigan, et al, Division of Land Use Management File No. 261-75-R.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. J. Shane Cadigan, et al petitioned on September 18, 1975, that the property described in Section 3 below be reclassified from RS-15,000 to SE and this application was assigned Division of Land Use Management File No. 261-75-R.

SECTION 2. The report and recommendation of the Division of Land Use Management was transmitted to the Zoning and Subdivision Examiner on November 18, 1975, and hearing was held by the Examiner on the matter November 25, 1975. The report of the Examiner was filed with the Clerk of the King County Council on February 11, 1976, and the Council approved the reclassification by Motion No. 2322 on February 23, 1976.

SECTION 3. The legal description of the property to be reclassified is attached as Appendix A and is hereby made a part of this ordinance. The above described property is shown on the attached map which is designated Appendix B and is hereby made a part of this ordinance.

SECTION 4. The King County Council does hereby amend King County Zoning Code, Resolution No. 25789, as amended, by reclassifying that property described and shown in Section 3, Appendices A and B above, to SE and directs
