ORDINANCE NO. 2673

AN ORDINANCE amending King County Zoning Resolution No. 25789, as amended, by amending the Zoning Map thereof reclassifying certain property thereon at the request of Charles McJunkin, Division of Land Use Management File No. 265-75-R.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Charles McJunkin petitioned on September 29, 1975, that the 16 property described in Section 3 below be reclassified from RS 7200 (Potential RM-2400) 17 to RD-3600 and this application was assigned Division of Land Use Management 18 File No. 265-75-R.

SECTION 2. The report and recommendation of the Division of Land Use Manage-20 ment was transmitted to the Zoning and Subdivision Examiner on November 18, 1975, 21 and hearing was held by the Examiner on the matter November 25, 1975. The 22 report of the examiner was filed with the Clerk of the King County Council on 23 December 19, 1975, and the Council approved the reclassification by Motion No. 2267 on January 12, 1976, subject to conditions which will be satisfied per the "P" suffix. SECTION 3. The legal description of the property to be reclassified is attached

26 as Appendix A and is hereby made a part of this ordinance. The above described 27 property is shown on the attached map which is designated Appendix B and is hereby 28 made a part of this ordinance.

SECTION 4. The King County Council does hereby amend King County Zoning 30 Code, Resolution No. 25789, as amended, by reclassifying that property described 31 and shown in Section 3, Appendices A and B above, to RD-3600-P and
