AN ORDINANCE amending King County Zoning Resolution No. 25789, as amended, by amending the Zoning Map thereof reclassifying certain property thereon at the request of ABC Corporation, Division of Land Use Management File No. 101-76-R.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. ABC Corporation, petitioned on November 13, 1975, that the property described in Section 3 below be reclassified from RM-2400 to RM-1800 and this application was assigned Division of Land Use Management File No. 101-76-R.

SECTION 2. The report and recommendation of the Division of Land Use Management was transmitted to the Zoning and Subdivision Examiner on January 6, 1976, and hearing was held by the Examiner on the matter January 13, 1976. The report of the Examiner was filed with the Clerk of the King County Council on February 4, 1976, and the Council approved the reclassification by Motion No. 2304 on February 9, 1976, subject to conditions which will be satisfied per the "P" suffix.
