10 AN ORDINANCE amending King County Zoning Resolution  
11 No. 25789, as amended, by amending the Zoning Map thereof  
12 reclassifying certain property thereon at the request of Joe  
Flaquinti, Building and Land Development Division File No. 217-74-P.

13 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

14 SECTION 1. Joe Flaquinti petitioned on March 12, 1974, that the property  
15 described in Section 3 below be reclassified from SR (Potential RM-2400) to  
16 RM-2400 and this application was assigned Building and Land Development  
17 Division File No. 217-74-P.

18 SECTION 2. The report and recommendation of the Building and Land  
19 Development Division was transmitted to the Zoning and Subdivision Examiner  
20 on April 30, 1974, and hearing was held by the Examiner on the matter May 7, 1974,  
21 and July 2, 1974. The report of the Examiner was filed with the Clerk of the  
22 King County Council on July 17, 1974, and the Council approved the reclass-  
23 ification by Motion No. 1653 on July 22, 1974 subject to conditions which have  
24 now been satisfied.

25 SECTION 3. The legal description of the property to be reclassified is  
26 attached as Appendix A and is hereby made a part of this ordinance. The above  
27 described property is shown on the attached map which is designated Appendix  
28 B and is hereby made a part of this ordinance.

29 SECTION 4. The King County Council does hereby amend King County  
30 Zoning Code, Resolution No. 25789, as amended, by reclassifying that property  
31 described and shown in Section 3, Appendices A and B above, to RM-2400 and
