AMENDMENT TO

WARRANT PURCHASE AGREEMENT

The Warrant Purchase Agreement of February 28, 1975 among the undersigned is amended by deleting the words "and interest thereon to January 1, 1978" from the fourth line of Section 2.1 thereof so that Section 2.1 now reads as follows:

2.1 From the effective date of this Agreement through September 30, 1977, the County may issue the Warrants in an amount not to exceed \$13,584,647.00, but in no event to exceed the amount authorized by appropriations for principal thereof, to pay that portion of lawful claims against the County now or hereafter incurred by County which shall have been certified by the County Division of Architecture to be in excess of the obligations or costs which on September 18, 1972, were anticipated by the County to be incurred in the construction of the Stadium. The Warrants shall be dated as of the date of issuance thereof, shall be payable from the "King County Stadium Supplemental Construction Fund" to be created by ordinance, and shall become interest bearing upon presentation for payment if there are then insufficient monies in that fund to pay such Warrants when presented. The Warrants shall be payable at the Head Office Branch of the Agent in Seattle, Washington.
