

ORDINANCE NO. 2737

1 AN ORDINANCE relating to the withdrawal of  
2 an area known as Lattimer from King County  
3 Water District No. 56.

## PREAMBLE:

4 King County Water District No. 56 has found  
5 the petition for withdrawal of an area known  
6 as Lattimer sufficient and by resolution  
7 concurred with the proposed withdrawal which  
8 is in the public interest and not inconsistent  
9 with the King County Comprehensive plan.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

10 SECTION 1. The area known as Lattimer shall hereby be with-  
11 drawn and excluded from King County Water District No. 56.

12 SECTION 2. The area known as Lattimer withdrawn by this  
13 ordinance from King County Water District No. 56 is described as  
14 follows:

15 The area of withdrawal herein described consists of  
16 portions of Marine Hills No. 17, portions of Marine  
17 Hills West, and portions of Tax Lot 13, SW 1/4 SE  
18 1/4 Section 32, Township 22 N., R. 4 E., W.M., to-  
19 gether with all of Marine Hills East, more particu-  
20 larly described as follows:

21 All of that portion of Marine Hills No. 17 lying  
22 within the SW 1/4 of Section 32, Township 22 N.,  
23 R. 4 E., W.M., which plat is recorded in Volume 98  
24 of Plats, page 50/52, Records of King County, Wash-  
25 ington; together with all that portion of Marine  
26 Hills West lying within Government Lot 4, Section  
27 5, Township 21 N., R. 4 East, W.M., which plat is  
28 recorded in Volume 98 of Plats, page 53/55, Records  
29 of King County, Washington; together with all of  
30 Marine Hills East as recorded in Volume 97 of Plats,  
31 page 76/77, Records of King County, Washington;  
32 together with all the unplatted land within the SW  
33 1/4 of the SE 1/4 of Section 32, Township 22 N. R.  
4 E., W.M., lying southwesterly of the centerline  
of Redondo Way S., and southerly of the north line  
of Lot 70 Marine Hills East, extended easterly to  
centerline of Redondo Way S.

All of the above parcels being generally located in the S 1/2 of Section 32, Township 22 N., R. 4 E., W.M. and Government Lot 4, Section 5, Township 21 N., R. 4 E., W.M.
