1 That UPLAKE Precinct shall be altered in the following manner,
2 and that the following described area, formerly a part of UPLAKE
3 Precinct be combined with and become a part of SHERIDAN Precinct:

4 That area lying south of the centerline of Northeast Bothell
5 Way; east of the centerline of 55th Avenue Northeast; west of the
6 centerline of 60th Avenue Northeast; and north of the Lake
7 Washington shoreline.

11TH LEGISLATIVE DISTRICT - 6TH COUNCIL DISTRICT

9 That RENTON 1 Precinct shall be altered in the following
10 manner, and the following described area, formerly a part of
11 RENTON 3 Precinct, shall be combined with and become a part of
12 RENTON 1 Precinct:

13 That area lying south of the centerline of North 8th St;
14 east of the centerline of Pelly Ave North and its extension; west
15 of the centerline of Park Ave North; and north of the centerline of
16 North 5th St.

17
18 That RENTON 4 Precinct shall be abolished and the following
19 described area, formerly known as RENTON 4 Precinct, be combined
20 with and become a part of RENTON 3 Precinct:

21 That area lying south of the centerline of North 8th St.;
22 east of the centerline of Meadow Ave. North; west of centerline of
23 Interstate Highway 405; and north of the centerline of North 4th St.

24
25 That RENTON 32 Precinct shall be altered in the following
26 manner, and that the following described area, formerly a part of
27 RENTON 3 Precinct; shall be combined with and become a part of
28 RENTON 32 Precinct:

29 That area lying south of the centerline of North 5th St;
30 east of the centerline of Pelly Ave North; west of the centerline
31 of Park Ave North; and north of the centerline of North 3rd St.

1 That RENTON 51 Precinct shall be altered in the following
 2 manner, and that the following described area, formerly a part of
 3 RENTON 51 Precinct, be combined with and become a part of
 4 RENTON 59 Precinct:

5 Beginning at the intersection of the center line of Burnett
 6 Avenue North and North 36th Street; thence west along the center-
 7 line of North 36th Street and its extension to its intersection
 8 with the centerline of Lake Washington Boulevard North; thence
 9 northerly along said centerline to its intersection with the north
 10 boundary of Government Lot 3, Lake Washington Shorelands; thence
 11 west along said north boundary to its intersection with the Lake
 12 Washington shoreline; thence northerly along said shoreline to its
 13 intersection with the centerline of the extension of the centerline
 14 of Burnett Ave. North; thence south to the point of beginning.

16 That WAYNE Precinct shall be altered in the following
 17 described manner:

18 That area within the west half of the east half of Section 31,

 21 right-of-way margin of the Valley Freeway (S.R. #167); north of
 22 the south line of the north half of the northwest quarter of the
 23 southeast quarter of said Section 31; and also including that
 24 portion of South 180th Street right-of-way lying between the
 25 easterly right-of-way margin of the East Valley Highway (Orillia
 26 Road) and the easterly right-of-way margin of the Valley Freeway
 27 (S.R. #167); and also including that portion of Talbot Road South
 28 right-of-way lying south of the current corporate limits of the
 29 City of Renton, and north of the south line of the north half of
 30 the northeast quarter of the southeast quarter of said Section 31;
 31 shall hereafter be and constitute a new precinct to be known as
 32 RENTON 60 Precinct.

4 That area lying south of the centerline of South 344th St.; east of
5 the centerline of the West Valley Rd.; west of the centerline of the
6 Chicago, Milwaukee, St. Paul and Pacific Railroad; and north of the center-
7 line of South 352nd St.

12 That JANE Precinct shall be abolished and the following described
13 area, formerly known as JANE Precinct, shall be combined with and become

16 of the centerline of 14th Ave. Southwest; west of the centerline of 12th
17 Ave. Southwest; and north of the centerline of Southwest 140th St.

19 33RD LEGISLATIVE DISTRICT - 7TH COUNCIL DISTRICT

21 That GRANADA Precinct shall be abolished and the following described
22 area, formerly known as GRANADA Precinct, shall be combined with and
23 become a part of ISABELLA Precinct:

24 That area lying south of the centerline of South 208th St.; east of
25 the centerline of 18th Ave. South; west of the centerline of 22nd Ave.
26 South; and north of the centerline of South 216th St.

1 That HELEN Precinct be abolished and the following described area,
2 formerly known as HELEN Precinct, shall be combined with and become a part
3 of SUNNYDALE Precinct:

8 That CARLETON Precinct be abolished and the following described area,

13 South; and north of the centerline of South 152nd St.

18 formerly a part of Precinct 43-60, shall be combined with and become a

21 Blvd. and East Lynn St.; thence east along the centerline of East Lynn
22 St. to its intersection with the centerline of Boyer Ave. East; thence
23 southeasterly along said centerline to its intersection with the centerline

25 intersection with the centerline of East Interlaken Blvd; thence north-
26 westerly along said centerline to the point of beginning.

4 Beginning at the intersection of the centerline of the extension
5 of East Howe St. and 16th Ave. East; thence north along the centerline
6 of the extension of 16th Ave. East to its intersection with the centerline
7 of East Interlaken Blvd.; thence easterly along said centerline to
8 its intersection with the centerline of 24th Ave. East; thence south
9 along said centerline to its intersection with the centerline of
10 Interlaken Pl. East; thence northerly along said centerline to its inter-
11 section with the centerline of 22nd Ave. East; thence southerly along
12 said centerline to its intersection with the centerline of East Crescent
13 Dr.; thence westerly along said centerline to its intersection with the
14 centerline of Interlaken Dr. ; thence northwesterly along said centerline
15 to its intersection with the centerline of the extension of East Howe St.;
16 thence westerly along said centerline to the point of beginning.

20 That BOTHELL 6 Precinct shall be altered and the following described
21 area shall constitute the boundaries of BOTHELL 6 Precinct:

22 That area lying south of the centerline of Northeast 205th St; east
23 of the centerline of 104th Ave. Northeast; west of the centerline of
24 Interstate Highway 405; and north of the east-west centerline of
25 Section 5, Township 26, Range 5.

27 That a new precinct BOTHELL 12 shall be created in the following
28 manner and the following described area, formerly a portion of BOTHELL 6
29 Precinct, shall constitute the boundaries of BOTHELL 12 Precinct:

1 Beginning at the intersection of the centerline of Northeast 205th
2 St. and the centerline of Interstate Highway 405; thence east along the
3 centerline of Northeast 205th St. to its intersection with the centerline
4 of 120th Ave. Northeast; thence south along said centerline to its
5 intersection with the centerline of Northeast 200th St.; thence east
6 along said centerline to its intersection with the current corporate
7 limits of the City of Bothell; thence southerly and easterly along said
8 corporate limits to its intersection with the centerline of 130th Ave.
9 Northeast; thence southerly along said centerline to its intersection
10 with the centerline of 130th Pl. Northeast; thence southeasterly along
11 said centerline to its intersection with the centerline of Northeast
12 190th St.; thence west along said centerline to its intersection with the
13 centerline of 130th Ave. Northeast; thence south along said centerline
14 to its intersection with the current corporate limits of the City of
15 Bothell; thence westerly and northerly and westerly along said corporate
16 limits to its intersection with the centerline of 116th Ave. Northeast
17 extension; thence south along said centerline to the centerline of
18 Interstate Highway 405; thence northerly along said centerline to the
19 point of beginning.

26 thence south along said centerline to its intersection with the center-
27 line of Northeast 190th St.; thence west along said centerline to its
28 intersection with the centerline of 100th Ave. Northeast; thence north

13 right of way; thence northeasterly along said railroad right of way to
14 its intersection with the west boundary of Tract 37 of the Kirkland
15 Juanita Acre Tracts; thence southerly and easterly along said boundary
16 to its intersection with the centerline of 116th Ave. Northeast; thence
17 north along said centerline to its intersection with the centerline of
18 Northeast 108th St.; thence east along said centerline to its intersection
19 with the centerline of Interstate Highway 405; thence southerly along
20 said centerline to its intersection with the centerline of Northeast 90th
21 St.; thence west along said centerline to its intersection with the
22 centerline of 116th Ave. Northeast; thence northerly along said centerline

20 boundary to its intersection with the east boundary of Section 32,
21 Township 23, Range 6, E.W.M.; thence south along the east boundary of
22 Sections 32 and 29, Township 23, Range 6, E.W.M. to its intersection with
23 the east-west centerline of Section 33, Township 23, Range 6, E.W.M.;
24 thence east along said centerline to its intersection with the east
25 boundary of Section 33, Township 23, Range 6, E.W.M.; thence north along
26 said boundary to its intersection with the north boundary of Section 34,
