## ORDINANCE NO. 2770

AN ORDINANCE appropriating \$4,001,260 to the CETA Title II Fund 00216 and \$28,549 to the CETA Title VI Fund 00243 from new grant funds; \$3,990,182 to provide for continuation of the CETA Title II Program; \$11,078 to provide for administrative costs of the CETA Title II Program; \$28,549 to provide for administrative costs of the CETA Title VI Program; decreasing previous appropriations to CETA Title II Fund 00216 by \$642,198; and amending Ordinance No. 2544, Section 55, as amended.

## PREAMBLE

King County has received a total of \$4,029,809 in grant funds from the King/Snohomish Manpower Consortium for continuation of its CETA Title II Program, for administrative costs of its Title II Program and for administrative costs of its Title VI Program. Appropriation of these grant funds is now required to allow continuation of the Title II Program and to cover 1976 costs of both the Title II and Title VI Programs.

The January, 1976 appropriation to CETA Title II Fund 00216 was \$1,302,550. The actual balance available to be carried over at year end 1975 was \$660,352. CETA Title II Fund 00216 is therefore over-appropriated by \$642,198.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. An appropriation of \$4,001,260 is hereby approved and adopted to CETA Title II Fund 00216; \$3,990,182 for program costs through December, 1976 and \$11,078 for administrative costs from January through June, 1976.

SECTION 2. The appropriation to CETA Title II Fund 00216 is hereby decreased by \$642,198 to adjust for the actual year end carryover balance.

SECTION 3. An appropriation of \$28,549 is hereby approved and adopted to CETA Title VI Fund 00243 for administrative costs from January through June, 1976.
