9 ORDINANCE NO. 2798

10 AN ORDINANCE amending King County Zoning Resolution
11 No. 25789, as amended, by amending the Zoning Map thereof
12 reclassifying certain property thereon at the request of
L.D. Quammen, Building and Land Development Division
File No. 214-76-R.

13 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

14 SECTION 1. L. D. Quammen petitioned on January 5, 1976, that the property
15 described in Section 3 below be reclassified from B-N to RS-7200 and this applica-
16 tion was assigned Building and Land Development Division File No. 214-76-R.

17 SECTION 2. The report and recommendation of the Building and Land Develop-
18 ment Division was transmitted to the Zoning and Subdivision Examiner on March
19 16, 1976, and hearing was held by the Examiner on the matter March 23, 1976.
20 The report of the Examiner was filed with the Clerk of the King County Council
21 on May 12, 1976, and the Council approved the reclassification by Motion No. 2478
22 on May 17, 1976.

23 SECTION 3. The legal description of the property to be reclassified is attached
24 as Appendix A and is hereby made a part of this ordinance. The above described
25 property is shown on the attached map which is designated Appendix B and is
26 hereby made a part of this ordinance.

27 SECTION 4. The King County Council does hereby amend King County Zoning
28 Code, Resolution No. 25789, as amended, by reclassifying that property described
29 and shown in Section 3, Appendices A and B above, to RS-7200 and directs that

1 Area Map E 3-21-4 be modified to so designate.



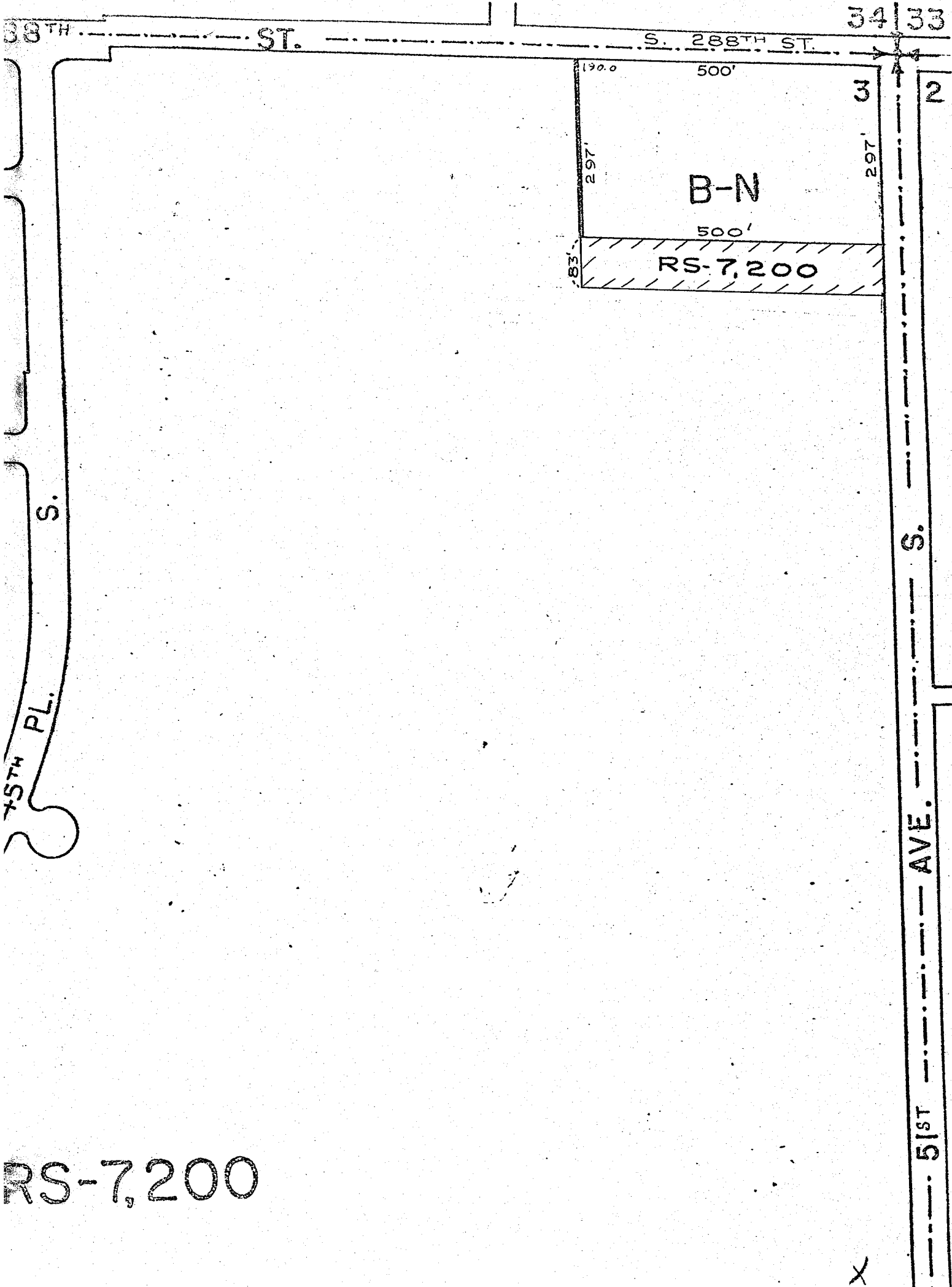
