 ORDINANCE NO. 2821

AN ORDINANCE relating to automobile rentals; providing for the location of automobile rentals in the B-C zone classification; amending Resolution 25789 Section 210 and KCC 21.04.070 and adding a new section thereto, and amending Resolution 25789 Section 1401 and KCC 21.28.020.

SECTION 1. Resolution 25789 Section 210 and KCC 21.04.070 are amended to read as follows: "Automobile, boat and trailer sales area" means an open area, other than a street, used for the display, and sale ((or rental)) of new or used automobiles; or the sale or rental of boats or trailers, and where no repair work is done except minor incidental repair of automobiles, boats or trailers to be displayed, sold or rented on the premises.

SECTION 2. NEW SECTION. There is added to Resolution 25789 and Chapter 21.04 KCC a new section to read as follows:

"Automobile rental" means an open area, or building, used for the parking and rental of automobiles, and where no repair work is done except minor incidental repair of automobiles to be rented on the premises.

SECTION 3. Resolution 25789 Section 1401 and KCC 21.28.020 are amended to read as follows: Any of the following types of uses which can meet the following standards are permitted and allowed by this classification subject to the limitations set forth herein:

(1) Any on-premises retail enterprise dispensing food or commodities (but not including automobiles, trailers, boats and heavy-duty equipment), and which may involve only incidental and limited fabrication or assembly of commodities;

	(2) Business offices and any type of use rendering professional
	services or personal services to the individual;
;	(3) Hospitals, except mental and alcoholic hospitals;
	(4) Hotels and motels, except apartment hotels;
	(5) Enterprises providing entertainment and recreation;
