AN ORDINANCE relating to the Vacation of a portion of South 283rd Street and Alley in Block 11, Redondo Beach Division No. 1. Security Savings & Loan Association & Others Petitioner:

## STATEMENT OF FACTS

- 1. A petition has been filed requesting vacation of a portion of South 283rd Street and Alley in Block 11, Redondo Beach Division No. 1, hereinafter described.
- The report of the Department of Public Works and the Division of . Building and Land Development, finds that the portion to be vacated is useless to the county and the vacation would not be in conflict with the principles and purposes of the Comprehensive Plan and the specific plans in the vicinity of the proposed vacation.
