AN ORDINANCE amending King County Zoning Resolution No. 25789, as amended, by amending the Zoning Map thereof reclassifying certain property thereon at the request of Kenneth A. Ball, et. ux, Building and Land Development Division File No. 226-76-R.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Kenneth A. Ball, et.ux, petitioned on March 3, 1976, that the property described in Section 3 below be reclassified from BC to RD-3600 and this application was assigned Building and Land Development Division File No. 226-76-R.

The report and recommendation of the Building and Land Development Division was transmitted to the Zoning and Subdivision Examiner on April 21, 1976, and hearing was held by the Examiner on the matter May 25, 1976.
