## ORDINANCE NO. \_

AN ORDINANCE relating to the annexation of an area known as Glendale Way South to Rainier Vista Sewer District.

WHEREAS, Rainier Vista Sewer District has found the petition for annexation of an area known as Glendale Way South to
sufficient and has, by resolution, concurred with the proposed
annexation; and

WHEREAS, state law requires approval of the proposed annexation by the King County Council and the King County Boundary
Review Board; and

WHEREAS, the King County Council finds said annexation is in the public interest and is not inconsistent with the county comprehensive plan;

THEREFORE, BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation by Rainier Vista Sewer District of the area known as Glendale Way South and described in Section 2 herein is approved.

SECTION 2. The area known as Glendale Way South to be annexed is described as follows:

Beginning at a point on the south line of Lot 6, Block 4, Hillmans Garden Tracts as recorded on Page 6, Volume 11 of Plats, King County, Washington, midway between the centerlines of 14th Ave. S. and 16th Ave. S.; thence west along said south line of Lot 6, 100 feet; thence north parallel to the centerline of 14th Ave. S. 128 feet to the south line of Lot 5 of said Block 4; thence west along said south line of Lot 6, 50 feet; thence northerly to a point on the south line of Lot 4 of said Block 4, 132 feet east of the east margin of 14 th Ave. S.; thence northwesterly to a point on the north line of said Lot 4, 65 feet east of east margin of 14th Ave. S.; thence west along north line of said Lot 4 to the east margin of 14th Ave. South;
