AN ORDINANCE relating to the annexation of an area known as 360th Street to Lakehaven Sewer District.

WHEREAS, Lakehaven Sewer District has found the petition for annexation of an area known as 360th Street to be sufficient and has, by resolution, concurred with the proposed annexation; and

WHEREAS, state law requires approval of the proposed annexation by the King County Council and the King County Boundary Review Board; and

WHEREAS, the King County Council finds said annexation is in the public interest and is not inconsistent with the county comprehensive plan,

THEREFORE, BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation by Lakehaven Sewer District of the area known as 360th Street and described in Section 2 herein is approved.

SECTION 2. The area known as 360th Street to be annexed is described as follows:
