 ORDINANCE NO.

AN ORDINANCE relating to setting a date of election for annexation of territory to Lakehaven Sewer District known as Geneva-Killarney.

PREAMBLE:

The requirements of RCW 56.24.070 and RCW 36.93.090, 36.93.093 and 36.93.100 for annexation of territory to a sewer district have been fulfilled by Lakehaven Sewer District.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The proposed annexation of territory known as Geneva-Killarney to Lakehaven Sewer District will be conducive to the public health, welfare and convenience and will be of special benefit to the land included within the boundaries of the territory proposed to be annexed.

day of homental proposed annexation as hereinafter described, between the hours of o'clock A.M. and so'clock P.M., for the purpose of submitting to the qualified electors within the territory proposed to be annexed the proposition of annexing said territory to Lakehaven Sewer District.

SECTION 3. The boundaries of the territory to be annexed to Lakehaven Sewer District are hereby described as follows:

Beginning at the Southeast corner of the Southwest quarter of the Southeast quarter of Section 22, Township 21 North, Range 4 East, W.M., in King County, Washington;

Thence Westerly along the South line of said Section 22, which is also the North line of Section 27, Township 21 North, Range 4 East, W.M., to a point 1397 feet West of the North quarter corner of said Section 27;

Thence Southwesterly to the intersection of the North line of the Southwest quarter of the Northwest quarter of said Section 27, and the West line of the East half of the West half of the Northwest quarter of said Section 27;

Thence Southerly along said West line to the East-West centerline of said Section 27;

Thence Westerly along said East-West centerline to the West line of said Section 27, which is also the Line of Section 28, Township 21 North, Range 4 East, W.M.;

Thence Northerly along said East line to its intersection with the North line of the South half of the North half of the Southeast quarter of the Northeast quarter of said Section 28;

Thence Westerly along said North line to its intersection with the East line of the West half of the Northeast quarter of said Section 28;

Thence Northerly along said East line and the East line of the West half of the Southeast quarter of Section 21, Township 21 North, Range 4 East, W.M., to its intersection with the South line of the North 480 feet of the Southeast quarter of the Southeast quarter of said Section 21;

Thence Easterly along said South line to its intersection with the East line of said Section 21, which is also the West line of said Section 22;

Thence Northerly along said West line to its intersection with the East-West centerline of Section 22;

Thence Easterly along said East-West centerline to its intersection with the East line of the West half of the West half of said Section 22;

Thence Northerly along said West line to its intersection with the Westerly extension of the North line of the plat of Evergreen Park Division No. 3 as recorded in Volume 49 of Plats, page 85, records of King County, Washington;

Thence Easterly along said Westerly extension and along the North line of Lots 17, 16, 15 and 14 of said plat of Evergreen Park Division No. 3 to the Southwest corner of the plat of Lake Geneva Park No. 2 as recorded in Volume 68 of Plats, page 36, records of King County, Washington;

Thence Northerly along the West line of said plat of Lake Geneva Park No. 2 to the Northwest corner of said plat;

Thence Easterly along the North line of said plat of Lake Geneva Park No. 2 and its Easterly extension to the North-South centerline of said Section 22;

Thence along said North-South centerline to its intersection with the Westerly extension of the North line of the Plat of Geneva Woods Addition as recorded in Volume 70 of Plats, page 31, records of King County, Washington;

Thence Easterly along the North line of said Plat of Geneva Woods Addition and its Westerly extension to the 2 Northeast corner of said plat; Thence Southerly along the East line of said plat of Geneva Woods Addition and its Southerly extension to its intersection with the centerline of South 342nd Street; 5 Thence Easterly along said centerline to its intersection with the centerline of 45th Avenue South; Thence Northerly along said centerline to its intersection with the Westerly extension of the North line of the plat of Tyche Park as recorded in Volume 85 of Plats, page 24, records of King County, Washington; 10 11 Thence Easterly along said Westerly extension and the North line of said plat of Tyche Park to the Northeast 12 corner of said plat; 13 Thence Southerly along the East line of said plat and the Southerly extension thereof to the centerline of 14 South 342nd Street; 15 Thence Easterly along said centerline to its intersection with the centerline of Military Road; 16 17 Thence Southerly and Southeasterly along the centerline of Military Road to its intersection with the East-West 18 centerline of said Section 22; Thence Westerly along said East-West centerline to a point 180 feet East of the West line of the Northeast 19 20 quarter of the Southeast quarter of said Section 22; 21 Thence Southerly along a line, 180 feet East of and parallel to the West line of the Northeast quarter of the Southeast quarter of said Section 22 to the South 22 line thereof; 23 Thence Westerly along said south line to the Northeast corner of the Southwest quarter of the Southeast 24 25 quarter of said Section 22; 26 Thence Southerly along the East line of said subdivision to the Southeast corner of said Southwest quarter of the Southeast quarter of said Section 22 and 27 the Point of Beginning. 28 29 SECTION 4.
