ORDINANCE NO. _____

AN ORDINANCE relating to the annexation of an area known as South 230th Street Extension (Lyle) to King County Water District No. 75.

STATEMENT OF FACT:

1. King County Water District No. 75 has found the petition for annexation of the area known as South 230th Street Extension (Lyle) to be signed by at least sixty percent of the owners of the area of the land for which annexation is petitioned per R.C.W. 57.24.070, and has by Resolution 76-6-2, passed on June 2, 1976, concurred with the proposed annexation per R.C.W. 57.24.090 and has thereby also reaffirmed Resolution 72-10-18F passed October 18, 1972.

2. King County Water District No. 75 filed a Notice of Intention with the King County Boundary Review Board dated June 1, 1976, as required in R.C.W. 36.93.090 and an environmental assessment has been filed with the King County Council in meeting the requirements of R.C.W. 42.21C, the State Environmental Policy Act guidelines, W.A.C. 197-10 and King County Ordinance No. 1700.

3. The Boundary Review Board has considered the factors set forth in R.C.W. 36.93.170 and has found the proposed annexation adequately meets the objectives enumerated in R.C.W. 36.93.180.

4. The King County Council held a hearing as set forth in R.C.W. 57.02.040, has considered the criteria enumerated in R.C.W. 57.02.040 and in Ordinances 1709 and 2638 and has found the proposed annexation to be adequately consistent with such criteria and in the public interest.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation by King County Water District No. 75 of the area known as South 230th Street Extension (Lyle) and described in Section 2 herein is approved.

2 (Lyle) to be annexed is described as follows:

3 Commencing at the intersection of 10th Avenue South
4 and South 230th Street;

5 Thence West along the center line of South 230th
6 Street to the center line of Marine View Drive;

7 Thence Northerly along the center line of Marine
8 View Drive to the center line of Kent - Des Moines
9 Road;

10 Thence Southeasterly along the center line of Kent -
11 Des Moines Road to the center line of 10th Avenue South;

12 Thence Southerly along the center line of 10th Avenue
13 south to the center line of South 230th Street and
14 the point of beginning.
