## ordinance no. 2886

AN ORDINANCE annexing an area known as Rancho Vista #2 (DS-43) to Des Moines Sewer District.

## STATEMENT OF FACT:

- 1. Des Moines Sewer District filed a July 15, 1976 Notice of Intentions indicating a petition for annexation of 3.9 acres of land was filed with the Districts Board of Commissioners signed by at least sixty percent of the land owners and by Resolution 1976-24 on June 23, 1976 the Board concurred with the proposed annexation. The District filed a June 3, 1976 statement of categorical exemption according to WAC 197-10-170 (18)(B). The District has a County-approved comprehensive plan as required in Ordinance 1709 as amended.
- 2. The Boundary Review Board has considered the criteria set forth in RCW 36.39.170 and has found that the proposed annexation adequately meets the objectives enumerated in RCW 36.93.180.
