## STATEMENT OF FACTS

- 1. A petition has been filed requesting vacation of a portion of South 209th Street, designated Race Street in the plat of the Southern Pacific Land Company's Second Addition to Des Moines.
- 2. The report of the Department of Public Works, the Division of Building and Land Development and the Real Property Division finds that the portion to be vacated is useless to the county and the vacation would not be in conflict with the principles and purposes of the Comprehensive Plan and the specific plans in the vicinity of the proposed vacation.
