9 AN ORDINANCE amending King County Zoning Resolution  
10 No. 25789, as amended, by amending the Zoning Map thereof  
11 reclassifying certain property thereon at the request of  
KLE, Inc., Building and Land Development Division File  
No. 244-76-R.

13 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

14 SECTION 1. KLE, Inc. petitioned on June 1, 1976, that the property  
15 described in Section 3 below be reclassified from RS-7200 to RM-900 and this  
16 application was assigned Building and Land Development Division File No. 244-76-R.

17 SECTION 2. The report and recommendation of the Building and Land Develop-  
18 ment Division was transmitted to the Zoning and Subdivision Examiner on July 20,  
19 1976, and hearing was held by the Examiner on the matter July 27, 1976. The  
20 report of the Examiner was filed with the Clerk of the King County Council on  
21 August 25, 1976, and the Council approved the reclassification by Motion No. 2660  
22 on August 30, 1976, subject to conditions which will be satisfied per the "P"  
23 suffix.

24 SECTION 3. The legal description of the property to be reclassified is  
25 attached as Appendix A and is hereby made a part of this ordinance. The above  
26 described property is shown on the attached map which is designated Appendix B  
27 and is hereby made a part of this ordinance.

28 SECTION 4. The King County Council does hereby amend King County Zoning  
29 Code, Resolution No. 25789, as amended, by reclassifying that property described  
30 and shown in Section 3, Appendices A and B above, to RM-900-P and directs

1 that Area Map E 8-21-4 be modified to so designate.

2 SECTION 5. This reclassification is granted subject to conditions adopted in  
3 Motion No. 2660 and said conditions are incorporated herein as though fully  
4 set forth herein.


