AN ORDINANCE relating to the Vacation of a portion

STATEMENT OF FACTS

- 1. A petition has been filed requesting vacation of a portion of 4th Avenue S.W., hereinafter described.
- 2. The report of the Department of Public Works and Transportation and Community and Environmental Development, Land Use Management Division, finds that the portion to be vacated is useless to the county and the vacation would not be in conflict with the principles and purposes of the Comprehensive Plan and the specific plans in the vicinity of the proposed vacation.
- 3. The vacation petition is in conformance with the terms of a rightof-way deed which was secured from Mr. Walter S. Myers and Grace Elzora Myers,
 the petitioners, in September of 1974. The acquired deed from the petitioner
 for the improvement and realignment of the 4th Avenue S.W. Right-of-Way project would constitute an exchange of properties.
- 4. It is believed that the public will benefit by the return of this unused area to the public tax rolls.

In consideration of the benefits to be derived from the subject vacation, the Council has determined that it is in the best interest of the citizens of King County to grant said petition.
