

ORDINANCE NO. 2989

2 AN ORDINANCE making an appropriation in the  
3 amount of \$247,000 to Special Programs from  
4 the unappropriated Current Expense Fund balance  
5 to subsidize the Building Modernization Con-  
6 struction Fund for the purchase of a 2.1 acre  
7 site referred to as the Myers Property, to be  
8 used for the construction of the proposed Burien  
9 Police/Court Building Capital Improvement Project  
10 No. 002016; amending the King County 1976 Capital  
11 Improvement Budget and amending Ordinance  
12 No. 2544, Section 43 and Section 68, attachment  
13 No. 1 as amended, and declaring an emergency.

14 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

15 SECTION 1. There is hereby approved and adopted an  
16 appropriation in the amount of \$247,000 to Special Programs from  
17 unappropriated Current Expense Fund balance to subsidize the  
18 Building Modernization Construction fund for the purchase of a  
19 2.1 acre site referred to as the Myers Property, to be used for  
20 the construction of the proposed Burien Police/Court Building  
21 Capital Improvement Project No. 002016.

22 SECTION 2. Ordinance No. 2544, Section 43, as amended,  
23 is hereby amended to read as follows:

25 SECTION 3. Ordinance No. 2544, Section 68, as amended, is

28 ((\$414,976)) \$661,976


29 SECTION 4. The project information sheets attached hereto



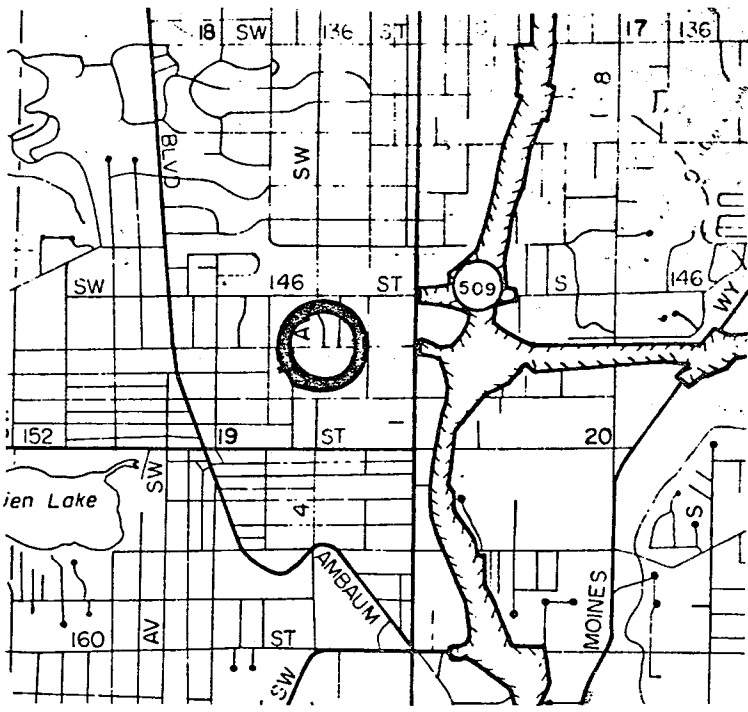
