BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Anna Mae Noreen petitioned on March 18, 1976, that the property described in Section 3 below be reclassified from S-R and S-R (Potential RM-900) to RM-900 and this application was assigned Building and Land Development Division File No. 228-76-R.
