### ORDINANCE NO. 3030

AN ORDINANCE declaring the abandonment of the Forward Thrust Park and Recreation Projects known as Scenic Highway Development; Puget Sound Boulevard, Shoreline and Marine View Improvements; McAleer Creek; Auburn and Enumclaw area local and neighborhood parks in presently unincorporated areas, and providing for the reallocation of these funds.

#### PREAMBLE:

WHEREAS, the County for energy conservation reasons no longer encourages recreational driving, and

WHEREAS, community opposition has strongly resisted the construction of Puget Sound Boulevard, Shoreline and Marine View Improvements, and

WHEREAS, it has become impractical to accomplish McAleer Creek due to opposition from the community and the City of Lake Forest Park, and

WHEREAS, the areas outside the cities of Auburn and Enumclaw are largely rural and inappropriate for the acquisition and development of small, passive neighborhood parks.

### BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Pursuant to Section 5 of King County Resolution 34571, and pursuant to the criteria in King County Motion 2192, the County finds that the following Forward Thrust Park and Recreation Projects have become impractical to substantially accomplish for reasons of community opposition, the inappropriateness of neighborhood park projects for rural areas and other changed conditions:

- A. Scenic Highway Development, Resolution 34571, Section 3K, (1); and Puget Sound Boulevard, and Shoreline and Marine View Improvements, Resolution 34571, Section 3K, (4); are hereby abandoned because the County no longer encourages recreational driving in order to conserve energy resources.
- B. McAleer Creek, Resolution 34571, Section 3C, (7) is hereby abandoned due to community and the City of Lake Forest Park opposition, and
- C. Auburn and Enumclaw area local and neighborhood parks in presently unincorporated areas, Resolution 34571, Section

3E, (4), are hereby abandoned due to the inappropri-ateness of small and passive neighborhood parks for largely rural areas outside the cities of Auburn and Enumclaw. SECTION 2. The County policy for the use of abandoned project bond funds, provided other requirements of Forward Thrust Resolution 34571 are satisfied, is that funds be made available for regional park and recreation needs and for meeting local park and recreational needs in the following areas: Vashon Island, Shoreline, West Central, Federal Way, Northshore, Eastside, Central, Kent-Auburn, Bear Creek, Southeast Central, East Central, Enumclaw, Snoqualmie Valley and East County per Attachment 1 hereto.
