ORDINANCE NO. 3059

AN ORDINANCE altering the 1977 operating budget in accord with the creation of a new executive Department of Youth Services, which contains functions formerly contained in the Juvenile Court and the Division of Youth Affairs, and amending Ordinance No. 2988, as amended, by changing Section 29, by deleting Sections 23 and 30 and adding a new section, and declaring an emergency.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Ordinance No. 2988, as amended, Section 29 is hereby amended to read as follows:

From the Current Expense Fund there is hereby appropriated to:

Superior Court ((\$3,405,984))

\$3,485,550

SECTION 2. Ordinance No. 2988, as amended, Section 23, is hereby repealed.

SECTION 3. Ordinance No. 2988, as amended, Section 30, is hereby repealed.

SECTION 4. Ordinance No. 2988, as amended, is hereby amended to read as follows:

NEW SECTION. YOUTH SERVICES. From the Current Expense Fund there is hereby appropriated to:

Youth Services

\$4,745,260

PROVIDED THAT:

1) \$346,000 of the appropriation shall be used only for contracts with the Youth Service Bureaus.

The Council intends that:

- 1. The Department report to the Council by March, 1977, the staff support provided to the Jobline program by the State Department of Employment Security in order that the Council can review the County's level of staffing for the Jobline program.
- 2. The Department report to the Council the level of the State's funding of the Special Supervision Program in order that the Council can consider potential budget adjustments which might be necessary to support the County's juvenile probation program.
