ORDINANCE NO. _3066

AN ORDINANCE relating to the annexation of an area known as Rancho Vista #6 to Des Moines Sewer District.

WHEREAS, Des Moines Sewer District has found the petition for annexation of an area known as Rancho Vista #6 to be sufficient and has, by resolution, concurred with the proposed annexation; and

WHEREAS, state law required approval of the proposed annexation by the King County Council and the King County Boundary Review Board; and

WHEREAS, the King County Council finds said annexation is in the public interest and is not inconsistent with the county comprehensive plan;

THEREFORE, BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation by Des Moines Sewer District of the area known as Rancho Vista #6 and described in Section 2 herein is approved.

SECTION 2. The area known as Rancho Vista #6 to be annexed is described as follows:

Beginning at the Northwest corner of the NE $\frac{1}{4}$ of the SE $\frac{1}{4}$ of the NW $\frac{1}{4}$ of Section 34, Township 23 North, Range 4 East, W.M.

Thence Southerly along the West line thereof to its intersection with a line 150 feet North of and parallel to the South line of the said NE $\frac{1}{4}$.

Thence Easterly along said parallel line to its intersection with the West line of Lot 7, Block 2, of Rancho Vista No. 6, according to Plat thereof recorded in Volume 61 of Plats, Page 86, Records of King County, Washington.

Thence Southerly along said West line to the Southwest corner of said Lot 7_r

Thence Easterly along the South line of said Lot 7 to the West margin of 41st Avenue South.

Thence Easterly across 41st Avenue South to the Southwest corner of Lot 7, Block 1, said Rancho Vista No. 6.
