AN ORDINANCE relating to the annexation of an area known as P-236RR (Lake Meridian Area) to Cascade Sewer District.

STATEMENT OF FACT:

1. Cascade Sewer District filed a July 12, 1976, Notice of Intention indicating a petition for annexation of 8.9 acres of land was sufficient, containing signatures of 60% of the land owners, and by Resolution 589 concurred with the proposed annexation. The District filed a Declaration of Environmental Nonsignificance, dated June 3, 1976, on the proposed annexation. The District has a County approved comprehensive plan as required in Ordinance No. 1709, as amended.

2. The Boundary Review Board has considered the criteria set forth in RCW 36.39.170 and has found that the proposed annexation adequately meets the objectives enumerated in RCW 36.93.180.

3. The King County Council held a public hearing on the 7th day of February, 1977, has considered the criteria set forth in RCW 56.02.060 and has found the proposed annexation to be adequately consistent with such criteria and to be in the public interest.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation by Cascade Sewer District of the area known as P-236RR (Lake Meridian Area) and described in Section 2 herein is approved.

SECTION 2. The area known as P-236RR (Lake Meridian Area) to be annexed is described as follows:

Beginning at the intersection of the East line of the West half of the West half of the Northeast quarter of the Northeast quarter and the South line of the Northeast quarter of the Northeast quarter of Section 27, Township 22 North, Range 5 East, W.M., King County, Washington, which is also a point on the existing Cascade Sewer District;

Thence Northerly along said East line of the West half of the West half of the Northeast quarter of the Northeast quarter of said Section 27, also being the West line of the plat of Carroll Estates as recorded in Volume 90 of Plats, page 6, records of King County, Washington to the North line of said plat of Carroll Estates, said North line being 660 feet Northeastly and parallel to the South line of the Northeast quarter of the Northeast quarter of said Section 27;

Thence Easterly along the North line of the South 660 feet of the Northeast quarter of the Northeast quarter of said Section 27 660 feet;

Thence Southerly along a line which is 660 feet East of and parallel to the East line of the West half of the West half of the Northeast quarter of the Northeast quarter of said Section 27 to the South line of the Northeast quarter of the Northeast quarter of said Section 27;

Thence Westerly along said South line to the Point of Beginning.
