3. The Capital Budget & Program provides for the acquisition of lands for the construction of a scale system at the 1st Avenue N.E. Transfer Site.

- 4. In order to acquire the property and property rights required to lay out and construct the Scale System at the 1st Avenue N.E. Transfer Site, it is necessary for King County to condemn certain lands and property rights and rights in property for public purposes as hereinafter more particularly set forth.
- 5. The King County Council finds that the public health, safety, necessity, convenience and welfare demand that the Scale System for the 1st Avenue N.E. Transfer Site be constructed in accordance with the King County Capital Budget and Program, and that certain properties, property rights and rights in property be condemned, appropriated, taken and damaged for the construction of said Scale System, as provided in this ordinance.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The King County Council has deemed it necessary and in the best interest of the citizens of King County that the lands hereinafter described, and other property rights and/or rights in property be condemned, appropriated, taken and damaged for the purpose of constructing the Scale System at the 1st Avenue N.E. Transfer Site, subject to the making or paying of just compensation to the owners thereof in the manner provided by law.
