## ORDINANCE NO.

AN ORDINANCE amending King County Zoning Resolution No. 25789, as amended, by amending the Zoning Map thereof reclassifying certain property thereon at the request of Harold F. Thompson, Building and Land Development Division File No. 170-76-R.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Harold F. Thompson petitioned on September 3, 1976, that the property described in Section 3 below be reclassified from RM-900 to C-G and this application was assigned Building and Land Development Division File No. 170-76-R.

SECTION 2. The report and recommendation of the Building and Land 19 Development Division was transmitted to the Zoning and Subdivision Examiner 20 on November 9, 1976, and hearing was held by the Examiner on the matter 21 November 16, 1976. The report of the Examiner was filed with the Clerk of the 22 King County Council on January 18, 1977, and the Council approved the reclassification by Motion No. 2849 on January 24, 1977, subject to conditions which will be satisfied per the "P" suffix.

SECTION 3. The legal description of the property to be reclassified is attached 26 as Appendix A and is hereby made a part of this ordinance. The above described property is shown on the attached map which is designated Appendix B and is hereby 28 made a part of this ordinance.

SECTION 4. The King County Council does hereby amend King County Zoning 30 Code, Resolution No. 25789, as amended, by reclassifying that property described 31 and shown in Section 3, Appendices A and B above, to C-G-P and directs that
