ORDINANCE NO.

AN ORDINANCE amending King County Zoning Code, Resolution No. 25789, as amended, by amending the Zoning Map thereof adopting an Unclassified Use Permit on certain property thereon at the request of Rainier National Bank, Building and Land Development Division File No. 260-76-U.

## BE IT ORDAINED BY THE COUNCIL OF KING COUNTY

SECTION 1. Rainier National Bank petitioned on August 4, 1976, for an Unclassified Use Permit to allow a private heliport on property described in Section 3 below and this application was assigned Building and Land Development Division File No. 260-76-U.

SECTION 2. The report and recommendation of the Division of Building and Land Development was transmitted to the Zoning and Subdivision Examiner on September 21, 1976, and hearing was held by the Examiner on the matter September 28, 1976. The report of the Examiner was filed with the Clerk of the King County Council on November 24, 1976, and the Council approved the reclassification by Motion No. 2780 on December 6, 1976, subject to conditions which have now been satisfied.

SECTION 3. The legal description of the property designated is attached as Appendix A and is hereby made a part of this ordinance. The above described property is shown on the attached map which is designated Appendix B and is hereby made a part of this ordinance. The development plan is designated Appendix C and is hereby made a part of this ordinance.

SECTION 4. As provided for in King County Zoning Code Resolution No. 25789, as amended, the King County Council does hereby grant the unclassified use permit to allow a private heliport described and shown in Section 3,
