AN ORDINANCE relating to the annexation of an area known as P-249 to Cascade Sewer District.

## STATEMENT OF FACT:

- 1. Cascade Sewer District filed a January 13, 1977, Notice of Intention indicating a petition for annexation of 70.23 acres of land was sufficient, containing signatures of 60% of the land owners, and by Resolution 625 concurred with the proposed annexation. The District filed a Declaration of Environmental Nonsignificance, dated January 13, 1977, on the proposed annexation. The District has a County approved comprehensive plan as required in Ordinance No. 1709, as amended.
- 2. The Boundary Review Board has considered the criteria set forth in RCW 36.39.170 and has found that the proposed annexation adequately meets the objectives enumerated in RCW 36.93.180.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation by Cascade Sewer District of the area known as P-249 and described in Section 2 herein is approved.

SECTION 2. The area known as P-249 to be annexed is described as follows:

Beginning at the East quarter corner of Section 21, Township 22 North, Range 5 East, W.M. in King County, Washington; said point being on the existing boundary of Cascade Sewer District;

Thence Southerly along the East line of said Section 21 to the South line of the North 850 feet of the Southeast quarter of the Southeast quarter of said Section 21;

Thence Westerly along said South line to the West line of the East 410 feet of the Southeast quarter of the Southeast quarter of said Section 21; (said line also being on the Southerly extension of the East line of the Plat of Terese Terrace as recorded in Volume 79 of Plats, pages 99 and 100, records of King County,
