ORDINANCE NO.

AN ORDINANCE relating to the Department of Public Safety's countywide radio emergency alerting system; amending Ordinance No. 3104, Section 1, and Ordinance No. 2988, Section 41, as amended.

PREAMBLE:

Ordinance No. 3104 erroneously appropriated to the Department of Public Safety \$32,491 from the Executive Contingency in Special Programs and \$54,381 from future federal reimbursements rather than \$33,491 and \$53,381, respectively.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Ordinance 3104, Section 1, is hereby amended to read as follows:

An appropriation of \$86,872 to the Department of Public Safety is hereby approved and adopted: ((\$32,49\frac{1}{2}\$)) \$33,49\frac{1}{2}\$ from the Executive Contingency in Special Programs and ((\$54,78\frac{1}{2}\$)) \$53,38\frac{1}{2}\$ from future federal reimbursements. The Department of Public Safety shall install a countywide radio alerting system, establish an emergency direction and control communications system for county executive departments responsible for providing emergency services during disasters, and is given authority through subgrant agreement, to allocate \$19,889 of federal reimbursables to the City of Bellevue for the installation of communication equipment as specified in the approved grant application.

SECTION 2. Ordinance 2988, Section 41, is hereby amended to read as follows:

<u>Special Programs</u> - From the Current Expense Fund there is hereby appropriated to:

PROVIDED THAT:
