ORDINANCE NO. _____

1 AN ORDINANCE relating to the Department of
2 Public Safety's countywide radio emergency
3 alerting system; amending Ordinance No. 3104,
4 Section 1, and Ordinance No. 2988, Section
5 41, as amended.

6 PREAMBLE:

7 Ordinance No. 3104 erroneously appropriated
8 to the Department of Public Safety \$32,491
9 from the Executive Contingency in Special
10 Programs and \$54,381 from future federal
11 reimbursements rather than \$33,491 and
12 \$53,381, respectively.

13 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

14 SECTION 1. Ordinance 3104, Section 1, is hereby amended
15 to read as follows:

16 An appropriation of \$86,872 to the Department of Public
17 Safety is hereby approved and adopted: (~~(\$32,491)~~) \$33,491
18 from the Executive Contingency in Special Programs and (~~(\$54,381)~~)
19 \$53,381 from future federal reimbursements. The Department of
20 Public Safety shall install a countywide radio alerting system,
21 establish an emergency direction and control communications
22 system for county executive departments responsible for pro-
23 viding emergency services during disasters, and is given
24 authority through subgrant agreement, to allocate \$19,889 of
25 federal reimbursables to the City of Bellevue for the instal-
26 lation of communication equipment as specified in the approved
27 grant application.

28 SECTION 2. Ordinance 2988, Section 41, is hereby amended
29 to read as follows:

30 Special Programs - From the Current Expense Fund there is
31 hereby appropriated to:

32 Special Programs (~~(\$5,867,527)~~) \$5,866,527

33 PROVIDED THAT:

- 1) The Executive Contingency of (~~(\$124,916)~~) \$123,916 shall not be expended unless the County Executive certifies in writing that funds are available and requests that the County Council adopt an additional

2 inance and signing by the Executive, funds may be
expended for the purposes specified.

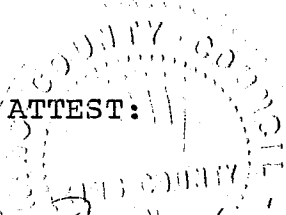
3 2) The provisos adopted by the Council in Ordinance 2988,
