1 AN ORDINANCE making an appropriation in  
2 the amount of \$33,500 to the Building  
3 Modernization Construction Fund from the  
4 Executive Contingency in Special Programs  
5 for the Federal Way Courthouse project;

7 Improvement Budget and amending Ordinance

10 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

11 SECTION 1. There is hereby approved and adopted an appro-  
12 priation in the amount of \$33,500 to the Building Modernization  
13 Construction Fund from the Executive Contingency in Special  
14 Programs for the Federal Way Courthouse, Capital Improvement  
15 Project No. 002069.

16 SECTION 2. Ordinance No. 2988, Section 41, as amended, is  
17 hereby amended to read as follows:

18 From the Current Expense Fund there is hereby appropriated  
19 to:

20 Special Programs \$5,866.527

21 PROVIDED THAT:

22 1) The Executive Contingency of (~~(\$127,916)~~) \$94,416  
23 shall not be expended unless the County Executive  
24 certifies in writing that funds are available and  
25 requests that the County Council adopt an additional  
26 appropriation ordinance; upon adoption of the ordi-  
27 nance and signing by the Executive, funds may be  
28 expended for the purposes specified.

29 2) All provisos adopted by the Council in Ordinance  
30 No. 2988 shall be fulfilled.

31 SECTION 3. Ordinance No. 2988, Section 70, as amended is  
32 hereby amended to read as follows:

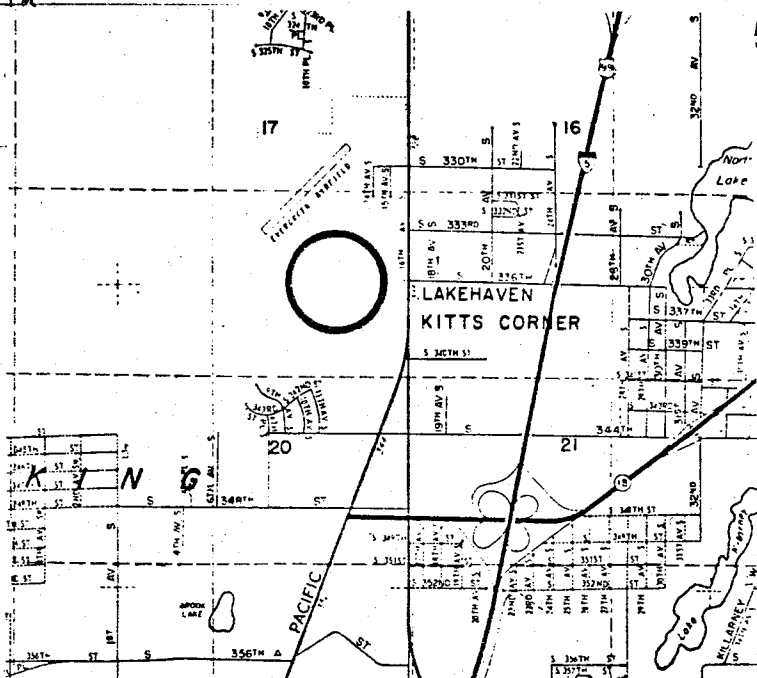
