SECTION 1. Don S. & Virginia L. Bussard petitioned on November 19, 1974, that the property described in Section 3 below be reclassified from RM-2400 to RM-900 and this application was assigned Building and Land Development Division File No. 103-75-R.

The report and recommendation of the Building and Land Development Division was transmitted to the Zoning and Subdivision Examiner on January 7, 1975, and hearings were held by the Examiner on the matter January 14, 1975, March 11, 1975, and March 25, 1975.
