ORDINANCE NO. 3189

2 AN ORDINANCE relating to the annexation of an
3 area known as Resolutions 129 and 130 to
4 Vashon Sewer District.

5 STATEMENT OF FACT:

6 1. Vashon Sewer District filed a September 23, 1976,
7 Notice of intention indicating a petition for
8 annexation of 60 acres of land was sufficient,
9 containing signatures of 60% of the land owners, and by
10 Resolutions 129 and 130 concurred with the proposed
11 annexation. The District filed a Declaration of
12 Environmental Nonsignificance, dated September 23,
13 1976, on the proposed annexation. The District has a
14 County approved comprehensive plan as required in
15 Ordinance No. 1709, as amended.

16 2. The Boundary Review Board has considered the
17 criteria set forth in RCW 36.39.170 and had found that
18 the proposed annexation adequately meets the objectives
19 enumerated in RCW 36.93.180.

20 3. The King County Council held a public hearing on
21 the 18th day of April, 1977, has
22 considered the criteria set forth in RCW 56.02.060 and
23 has found the proposed annexation to be adequately
24 consistent with such criteria and to be in the public
25 interest.

26 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

27 SECTION 1. The annexation by Vashon Sewer District of the
28 area known as Resolutions 129 and 130 and described in Section-2
29 herein is approved.

30 SECTION 2. The area known as Resolutions 129 and 130 to be
31 annexed is described as follows:

32 Part of the SE 1/4 of Section 30, and part of the NE
33 1/4 of Section 31, Township 23 North, Range 3 East,
W.M. King County, Washington being more particularly
described as follows:

The S 1/2 of the S 1/2 of the SE 1/4 of Section 30
EXCEPT the East 660 feet thereof;

1 And also the N 1/2 of the N 1/2 of the NE 1/4 of
2 Section 31, EXCEPT the East 660 feet thereof.
