ORDINANCE NO. **3255**

2 AN ORDINANCE appropriating \$42,800 from
3 unappropriated Current Expense Fund balance
4 to Special Programs for planning assistance
5 to suburban cities and towns of King County,
6 and providing for an obligation and making
7 provision for repayment of \$42,800 to the
8 Current Expense Fund from the Community
9 Development Block Grant Fund and amending
10 Ordinance No. 2988, Sections 41 and 55, as
11 amended.

12 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

13 SECTION 1. FINDINGS.

- 14 (a) Sound and accepted areawide land use policy requires
15 the full involvement and cooperation of suburban
16 cities and towns in the development of said policy;
17 (b) Suburban cities and towns are often hindered by a
18 lack of resources from effectively participating in
19 areawide policies;
20 (c) A specific objective of the federal Housing and Community
21 Development Act of 1974 is "a more rational utilization
22 of land and other natural resources and the better
23 arrangement of residential, commercial, industrial,
24 recreational, and other needed activity centers";
25 (d) King County has previously allocated Community Develop-
26 ment Block Grant funds to assist suburban cities and
27 towns to participate in planning for more rational
28 land uses;
29 (e) Federal Block Grant regulations permit the reimbursement
30 of previously incurred costs "where such costs are
31 to complete activities previously approved under the
32 Block Grant Program...."

33 SECTION 2. There is hereby approved and adopted an appro-
priation of \$42,800 from unappropriated Current Expense Fund
balance for funding planning assistance to suburban cities and
towns as outlined in Motion No. 03003.

SECTION 3. The total appropriation of \$42,800 is an obligation to be repaid to the Current Expense Fund from the Housing and Community Development Fund after approval is received from the federal government of the 1978 Block Grant Application.

SECTION 4. Ordinance No. 2988, Section 41, as amended, is hereby amended to read as follows:

From the Current Expense Fund there is hereby appropriated to:

Special Programs ((~~\$3,936,159~~)) \$3,978,959

SECTION 5. Ordinance No. 2988, Section 55, as amended, is hereby amended to read as follows:

Community Development Block Grant Fund

((~~\$8,705,574~~)) \$8,748,374

SECTION 6. EFFECTIVE DATE. This ordinance shall not take effect prior to July 2, 1977.
