ORDINANCE NO. 32

AN ORDINANCE appropriating \$42,800 from unappropriated Current Expense Fund balance to Special Programs for planning assistance to suburban cities and towns of King County, and providing for an obligation and making provision for repayment of \$42,800 to the Current Expense Fund from the Community Development Block Grant Fund and amending Ordinance No. 2988, Sections 41 and 55, as amended.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. FINDINGS.

- (a) Sound and accepted areawide land use policy requires the full involvement and cooperation of suburban cities and towns in the development of said policy;
- (b) Suburban cities and towns are often hindered by a lack of resources from effectively participating in areawide policies;
- (c) A specific objective of the federal Housing and Community

 Development Act of 1974 is "a more rational utilization

 of land and other natural resources and the better

 arrangement of residential, commercial, industrial,

 recreational, and other needed activity centers";
- (d) King County has previously allocated Community Development Block Grant funds to assist suburban cities and towns to participate in planning for more rational land uses;
- (e) Federal Block Grant regulations permit the reimbursement of previously incurred costs "where such costs are to complete activities previously approved under the Block Grant Program..."

SECTION 2. There is hereby approved and adopted an appropriation of \$42,800 from unappropriated Current Expense Fund balance for funding planning assistance to suburban cities and towns as outlined in Motion No. 03003.
