ORDINANCE NO.

AN ORDINANCE amending King County Zoning Resolution No. 25789, as amended, by amending the Zoning Map thereof reclassifying certain property thereon at the request of Joseph V. Starkovich, Building and Land Development Division File No. 205-77-R.

BE IN ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Joseph V. Starkovich petitioned on December 1, 1976, that the property described in Section 3 below be reclassified from S-R to M-P and this 16 application was assigned Building and Land Development Division File No. 205-77-R.

SECTION 2. The report and recommendation of the Building and Land Develop-18 ment Division was transmitted to the Zoning and Subdivision Examiner on January 18, 19 1977, and hearing was held by the Examiner on the matter January 25, 1977. The 20 report of the Examiner was filed with the Clerk of the King County Council on 21 March 28, 1977, and the Council approved the reclassification by Motion No. 2952 22 on April 4, 1977, subject to conditions which will be satisfied per the M-P plot 23 plan approval.

SECTION 3. The legal description of the property to be reclassified is attached as Appendix A and is hereby made a part of this ordinance. The above described 26 property is shown on the attached map which is designated Appendix B and is here-27 by made a part of this ordinance.

SECTION 4. The King County Council does hereby amend King county Zoning 29 Code, Resolution No. 25789, as amended, by reclassifying that property described 30 and shown in Section 3, Appendices A and B above, to M-P and directs that Area
